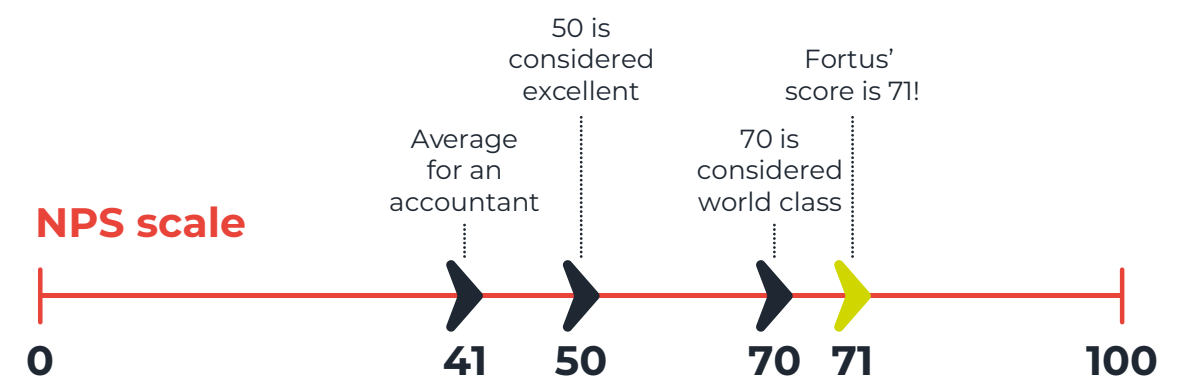

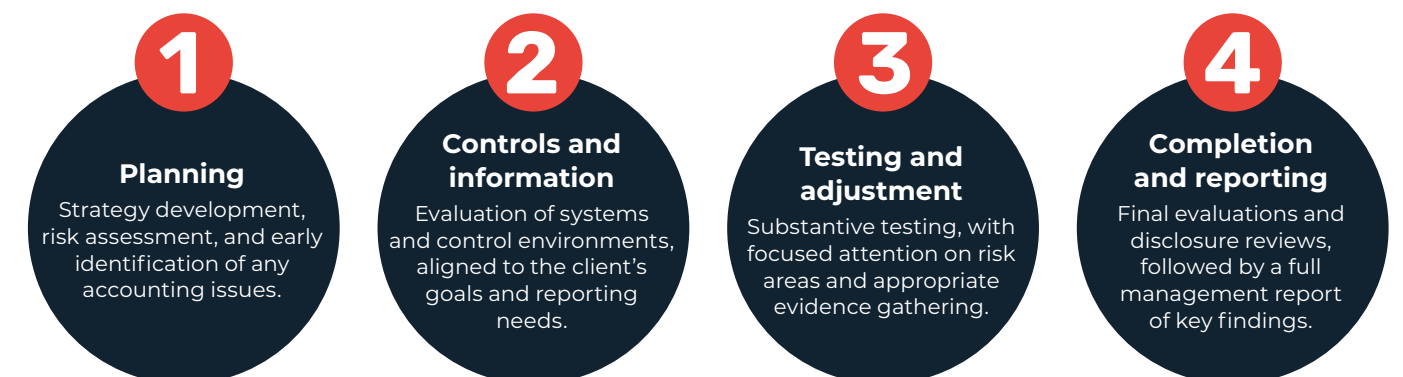
We break our audit style into six core principles:

Charging fairly
